CALIENTE BARE DARE 5K – MAY 3, 2015 POSTRACE REPORT - PROMOTIONAL IMPACT

The sixth-annual, clothing-optional Caliente Bare Dare 5K took place on Sunday, May 3, 2015 at Pasco County's Caliente Resort in Land O'Lakes.

There were 296 registered participants, 261 finishers, and approximately 125 additional spectators/guests for the event representing 22 states, along with Ecuador and Canada. The 22 states represented were Alabama, Arizona, Arkansas, California, Colorado, Florida, Georgia, Hawaii, Illinois, Maryland, Massachusetts, Michigan, New Hampshire, New Jersey, New York, North Carolina, Ohio, Pennsylvania, South Carolina, Tennessee, Texas, and Wisconsin.

The Caliente Bare Dare 5K continues to draw athletes from more states than any other endurance sports event in Florida with the exception of Ironman Florida in Panama City and the Disney Marathon in Lake Buena Vista.

Race director Pete Williams, CEO of race organizer Enterprise Media LLC, again did numerous media interviews in the weeks leading up to the race, always emphasizing

Pasco County as a premier destination for endurance sports in Florida. In the last two years, the Caliente Bare Dare 5K has been featured in Runner's World magazine, Women's Running magazine, Competitor magazine, The Tampa Tribune, and The Sarasota Herald-Tribune, along with more than a dozen top blogs. It also was mentioned prominently in the best-selling book "The Runner's Bucket List." Locally it's also been featured by WFLA 970 News Radio and by ABC 28 WFTS Television and WFLA NBC Channel 8 Television. A Google search of "Caliente Bare Dare 5K" includes more than 150 mentions of the race in the last two years alone.

In 2015, we partnered with 102.5 The Bone FM, one of the most popular stations in Tampa Bay, and received dozens of 15-second ads, along with numerous mentions by on-air staff.

The Pasco County location of the Caliente Bare Dare 5K was promoted heavily in weekly e-blasts on Constant Contact going out to 2,500 runners. The race also was promoted via e-blasts by Florida RacePlace magazine as well as by the Caliente Resort, which has more than 10,000 people on its weekly e-blast. The Pasco County logo also is positioned prominently on www.nuderaces.com, the official website of Enterprise Media LLC, which receives 6,000 and 10,000 unique visits a month.

Enterprise Media LLC continues to aggressively promote the Caliente Bare Dare 5K and Pasco County, distributing more than 5,000 promotional postcards at events in Central Florida. Advertising also was taken out in Florida RacePlace magazine. Calendar listings were placed at more than a dozen prominent running websites and constant updates were provided on the Caliente Bare Dare 5K Facebook page, which has approximately 1,000 followers.

Four different Pasco County brochure flyers were placed in the more than 300 goody bags distributed on race day and Pasco banners were hung above the registration tent. (Because photography is expressly prohibited at Caliente, photos were not taken.) Two Pasco County towels, provided by Pasco, were given to the male and female winners as part of their prize packages. Williams, who also serves as emcee for the Caliente Bare Dare 5K, mentioned Pasco prominently in all pre-race and post-race announcements. In addition, Enterprise Media LLC hired a Pasco EMS unit for the race for a cost of \$390.00.

Caliente Resort reported 94 room nights as a result of the race (see attached). Since Caliente sold out its accommodations more than a month in advance of the race, the event likely accounted for many more nights between the neighboring clothing-optional Paradise Lakes and Lake Como Resorts (both in Pasco County), along with nearby Pasco hotels.

The Caliente Bare Dare 5K has attracted some of the top endurance athletes from around the country in its first six years, with male and female winners posting times comparable to those of much larger races. Since 2012 the Caliente Bare Dare 5K has determined the National Championship of Nude Running and the event attracts a

more competitive field each year. In 2015, the women's course record was shattered by more than 90 seconds and now stands at 17:53.

The Caliente Bare Dare 5K is staged by Enterprise Media, LLC, which also produces the web site EnduranceSportsFlorida.com, a top resource for news and information in the Sunshine State. The event is promoted aggressively via that site, along with the nuderaces.com and obstaclefit.com websites, which also are owned by Enterprise Media.

Enterprise Media has aggressively promoted the Caliente Bare Dare 5K, generating as much if not more media exposure for Pasco County than any other endurance sports event. It also has generated more publicity for Caliente Resort, North America's largest clothing-optional facility, than any other Caliente event. Since partnering with Pasco County in 2012, the Caliente Bare Dare 5K has almost doubled in size.

The seventh-annual Caliente Bare Dare 5K will take place at Pasco's Caliente Resort on Sunday, May 1, 2016.




