Notice of Privacy Practices

HIPAA

THIS NOTICE DESCRIBES HOW HEALTH INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED AND HOW YOU CAN GET ACCESS TO THIS INFORMATION. PLEASE REVIEW IT CAREFULLY.

### WHO WILL FOLLOW THIS NOTICE

This notice describes PCPT's practices and that of:

- All health related departments and programs of PCPT.
- All employees, staff and contractors of PCPT.

All these entities, sites and locations follow the terms of this notice. In addition, these entities, sites and locations may share health information with each other for service, payment or health care operations purposes described in this notice.

### OUR PLEDGE REGARDING PERSONAL HEALTH INFORMATION (PHI)

We understand that information about you and your health is personal. We are committed to protecting your PHI. We create a record of the services you receive as a client of PCPT. We need this record to provide you with quality service and to comply with certain legal requirements. This notice applies to all of the records of your service generated by PCPT, whether made by PCPT personnel, a provider or a business associate whom we contract with. This notice will tell you about the ways in which we may use and disclose your PHI. We also describe your rights and certain obligations we have regarding the use and disclosure of PHI.

### We are required by law to:

- Make sure that PHI that identifies you is kept private (with certain exceptions);
- Give you this notice of our legal duties and privacy practices with respect to your PHI; and follow the terms of the notice that is currently in effect.

### HOW WE MAY USE AND DISCLOSE PHI ABOUT YOU

The following categories describe different ways that we use and disclose health information. For each category of uses or disclosures we will explain what we mean and try to give some examples. Not every use or disclosure in a category will be listed. However, all of the ways we are permitted to use and disclose information will fall within one of the following categories:

#### For Service

We may use your health information to provide you with transportation services. We may disclose your health information (upon written authorization from you) to doctors, nurses or other persons providing health services to you in order to verify your eligibility to receive transportation services. For example, a doctor treating you will know any physical disability that may prohibit you from using transit. This information would be useful in selecting the most appropriate mode of transportation for you.

#### For Payment

We may use and disclose your health information to others for purposes of receiving payment for transportation services that you receive.

#### For Health Care Operations

We may use and disclose your health information for operational purposes. These uses and disclosures are necessary to operate PCPT and make sure that all of our participants receive quality transportation. For example, we may use health information to review our services and to evaluate the performance of our staff in transporting you.

#### Service Alternatives

We may use your health information to provide you with information about or recommend possible transportation alternatives that may be of interest to you.

#### Individuals Involved in Your Service or Payment for Your Service

We will disclose your health information to a friend, family member or significant other who is involved in your health care or who helps pay for your care only if we obtain your written authorization. Your written authorization should be provided on the **Disclosing Health Information to Family Members or Those Involved in a Client's Care** form. #### As Required By Law

We may disclose your health information when required to do so by federal, state or local law. For example, PCPT may disclose information for the following purposes:

- Court orders and court-ordered warrants;
- Subpoenas or summons issued by a court, grand jury, a governmental or tribal inspector general, or an administrative body authorized to require the production of information;
- A civil or an authorized investigative demand;
- Medicare conditions of participation with respect to health care provider participation in the program;
- Statutes or regulations that require the production of information, including statutes or regulations that require such information if payment is sought under a government program providing public benefits.

#### To Avert A Serious Threat to Health or Safety

We may disclose your health information when necessary to prevent a serious and imminent danger of violence to your health and safety or the health and safety of the public or another person. Any disclosure, however, would only be to the target of the threat or to someone able to help prevent the threat.

#### Public Health Related Activities

We may disclose your health information for public health activities. These activities generally include the following:

- To prevent or control disease;
- To report the abuse or neglect of children, elders, and dependent adults;
- To notify a person who may have been exposed to a disease or may be at risk for contracting or spreading disease or condition.

#### Victims of Abuse, Neglect or Domestic Violence

We may disclose your health information to a government authority if asked to do so by a law enforcement official and the disclosure is required by law, necessary to prevent serious harm to the individual or other potential victims, or if you agree. If such a disclosure is made, we will make every effort to promptly inform you, with certain exceptions.

#### Health Oversight Activities

We may disclose your health information to a health oversight agency for activities authorized by law. These oversight activities include, for example, audits, investigations, inspections, and licensure. These activities are necessary for the government to monitor the health care system, government programs, and compliance with civil rights law.

#### Law Enforcement

We may disclose your health information if asked to do so by a law enforcement official:

- In response to a court order, subpoena, warrant, summons or similar process;
- To identify or locate a suspect, fugitive, material witness, or missing person;
- About the victim of a crime if, under certain limited circumstances, we are unable to obtain the person's agreement;
- About a death we believe may be the result of criminal conduct;
- About criminal conduct at PCPT; and
- In emergency circumstances to report a crime; the location of the crime or victims; or the identity, description or location of the persons who committed the crime.

## Coroners, Medical Examiners and Funeral Directors

We may disclose your health information to a coroner or medical examiner. This may be necessary, for example, to identify a deceased person or determine the cause of death. We may also disclose your health information to funeral directors as necessary to carry out their duties.

## Specialized Governmental Functions

We may disclose your health information to authorized federal officials for intelligence, counterintelligence, and other national security activities authorized by law.

We may disclose your health information to authorized federal officials so they may provide protection to the President, other authorized persons or foreign heads of state to conduct authorized investigations.

## OTHER USES OF YOUR HEALTH INFORMATION

Other uses and disclosures of your health information not covered by this notice or the laws that apply to us will be made only with your written authorization. If you provide us with authorization to use or disclose your health information, you may revoke that authorization, in writing, at any time. If you revoke your authorization, this will stop any further use or disclosure of your health information for the purposes covered by your written authorization, except if we have already acted in reliance on your authorization.

## YOUR RIGHTS REGARDING YOUR HEALTH INFORMATION

You have the following rights regarding your health information that we maintain:

### Right to Inspect and Copy

You have the right to inspect and copy your health information that is used to make decisions about services provided to you. Usually, this includes health and billing records, but may not include some mental health information. To inspect and copy health information that is used to make decisions about you, you must submit your request in writing to the COUNTY'S Chief Privacy Officer, Barbara DeSimone, West Pasco Government Center, 7530 Little Road, New Port Richey, Florida 34654. Telephone: 727-847-8103. If you request a copy of the information, we may charge a fee for the costs of copying, mailing or other supplies associated with your request.

We may deny your request to inspect and copy in certain very limited circumstances. If you are denied access to your health information, you may request that the denial be reviewed. Another licensed health care professional chosen by the agency will review your request and the denial. The person conducting the review will not be the person who denied your request. We will comply with the outcome of the review.

### Right to Amend

If you feel that your health information is incorrect or incomplete, you may ask us to amend the information. You have the right to request an amendment for as long as the information is kept by or for the agency.

To request an amendment, your request must be made in writing on PCPT's Request to Amend Health Information form. This form can be obtained from and then submitted to the COUNTY'S Chief Privacy Officer, Barbara DeSimone, West Pasco Government Center, 7530 Little Road, New Port Richey, Florida 34654. Telephone: 727-847-8103. In addition, you must provide a reason that supports your request.

We may deny your request for an amendment if it is not in writing or does not include a reason to support the request. In addition, we may deny your request if you ask us to amend information that:

- Was not created by us, unless the person or entity that created the information is no longer available to make the amendment;
- Is not part of the medical information kept by or for PCPT, i.e., not part of your medical record;
- Is not part of the information which you would be permitted to inspect and copy; or
- Is accurate and complete;

Even if we deny your request for amendment, you have the right to submit a written addendum, not to exceed 250 words, with respect to any item or statement in your record you believe is incomplete or incorrect. If you clearly indicate in writing that you want the addendum to be made part of your medical record we will attach it to your records and include it whenever we make a disclosure of the item or statement you believe to be incomplete or incorrect.

### Right to an Accounting of Disclosures

You have the right to request an accounting of disclosures. This is a list of the disclosures we made of your health information other than our own uses for service, payment and transportation operations, (as those functions are described above) and with other expectations pursuant to the law, e.g., disclosures that you have authorized.

To request this list or accounting of disclosures, you must submit your request in writing on PCPT's Request for an Accounting of Disclosures form. This form can be obtained from and then submitted to COUNTY'S Chief Privacy Officer, Barbara DeSimone, West Pasco Government Center, 7530 Little Road, New Port Richey, Florida 34654. Telephone: 727-847-8103. Your request must state a time period, which may not be longer than six years and may not include dates before April 14, 2003. The first list you request within a 12 month period will be free. For additional lists, we will charge you for the costs of providing the list. We will notify you of the cost involved and you may choose to withdraw or modify your request at that time before any costs are incurred.

### Right to Request Restrictions

You have the right to request a restriction of the use or disclosure of your health information to carry out service, payment or transportation operations. - **We are not, however, required to agree to your request.** If we do agree, we will comply with your request unless the information is needed to provide you emergency treatment.

To request a restriction, you must make your request in writing on PCPT's Request for Restriction on the Use or Disclosure of Health Information. This form can be obtained from and then submitted to COUNTY'S Chief Privacy Officer, Barbara DeSimone, West Pasco Government Center, 7530 Little Road, New Port Richey, Florida 34654. Telephone: 727-847-8103. In your request, you must tell us (1) what information you want to limit; (2) whether you want to limit our use, disclosure or both; and (3) to whom you want the limits to apply, for example, disclosures to your spouse.

### Right to Request Confidential Communications

You have the right to request that we communicate with you about medical matters in a certain way or at a certain location. For example, you can ask that we only contact you at work or by mail. To request confidential communications, you must make your request in writing on PCPT's Request for Restriction on the Manner/Method of Confidential Communication form. This form can be obtained from and then submitted to COUNTY'S Chief Privacy Officer, Barbara DeSimone, West Pasco Government Center, 7530 Little Road, New Port Richey, Florida 34654. Telephone: 727-847-8103. We will not ask you the reason for your request and we will accommodate all reasonable requests. Your request must specify how or where you wish to be contacted.

### Right to a Paper Copy of This Notice

You have the right to a paper copy of this notice. You may ask us to give you a copy of this notice at any time. Even if you have agreed to receive this notice electronically, you are still entitled to a paper copy of this notice. To obtain a paper copy of this notice contact the COUNTY'S Chief Privacy Officer, Barbara DeSimone, West Pasco Government Center, 7530 Little Road, New Port Richey, Florida 34654. ## CHANGES TO THIS NOTICE

We reserve the right to change this notice. We reserve the right to make the revised or changed notice effective for health information we already have about you as well as any information we receive in the future. We will post a copy of the current notice at PCPT. Additionally, when changes are made to the notice, we will mail the revised notice to all patients, clients, and participants treated in the preceding twelve months prior to the change.

## COMPLAINTS

You will not be penalized for filing a complaint. If you believe your privacy rights have been violated, you may file a complaint with the County or with the Secretary of the Department of Health and Human Services.
